C. Additional comments to support AJD: [A portion of the area shows up on NWI as a forested wetland for this area. However an on-site investigation \(data sheets included\) revealed this is not correct. The vegetation was dominated by Kentucky bluegrass \(Poa pratensis\) and other yard grasses. Site is currently upland mown yard at the same elevation as the adjacent home and garage. There does appear to be a wetland area outside of the review area to the east in the woods.](#)
