Fluke, Wetland	2.28 acres	(b)(1) Non-adjacent wetland	The area exhibiting wetland characteristics observed during the site inspection is a forested, scrub/shrub, and emergent complex approximately 2.28 acres in size. Based on the site inspection, review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps, the geographic location of the area exhibiting wetland characteristics, in relation to the nearest tributary (John Diehl Ditch approximately 330 feet east of the review area), does not meet adjacency criteria. Based upon the site inspection, the area does not directly abut an (a)(1) – (a)(3) water, is not physically separated by a natural feature from an (a)(1) – (a)(3) water, nor is it physically separated by an artificial structure, dike, barrier, etc., that has a direct hydrologic connection to a (a)(1) – (a)(3) water. The nearest FEMA mapped AE flood zone (1% annual chance of flooding) is approximately 1.7 miles south of the review area, indicating the geographic location of the area exhibiting wetland characteristics precludes inundation by floodwater in a typical year from a (a)(1) – (a)(3) water.
