C. Additional comments to support AJD: The review area consists of an approximate 1-acre pond situated at the northern end of a 2.23-acre parcel within a commercially developed urban area. The southern portion of the parcel has been previously developed. The pond is surrounded by an approximate 10 foot wide area of scrub/shrub wetland waterward of a man-made berm. Based on the site review and applicable resource maps, the pond is not located near a jurisdictional water, therefore, is not subject to inundation by flood waters. No culvert or other such structure, that would allow the pond to contribute to surface water flow to a downstream water at least once in a typical year, was observed during the July 14, 2021 site visit. It has therefore been determined that the pond within the review area is an excluded water under the (b)(1) exclusion, a lake/pond or impoundment that does not contribute surface water flow directly or indirectly to an (a)(1) water, and is not inundated by flooding from an (a)(1)-(a)(3) water in a typical year.
