area. The 2020 aerial photo depicts what appear to be wet signatures along the northern edge of the farm field. These areas are located within an agricultural field that was planted with soybeans during the 2021 growing season. The data points taken by the consultant on August 31, 2021 near the area of the mapped NWI wetland and within the areas of the potential wet signatures depicted in the 2020 aerial (T1P4, T1P3, and T2P5) document the lack of hydrophytic vegetation and hydrology indicators. At the November 16, 2021 site inspection, an erosional feature was observed in the upland farmfield in proximity of the area of the NWI mapped wetland. This erosional feature in the upland farm field exhibited drainage patterns leading to what appeared to be an off-site wetland in the area of the NWI mapped PFO wetland. The erosional feature did not have a defined bed and bank or Ordinary High Water Mark, and therefore was not considered a potential water of the United States. None of the areas investigated within the upland farm field on November 16, 2021 supported hydrophytic vegetation, confirming the data presented in the September 7, 2021 delineation report. Additionally, based upon a review of aerial imagery and information provided in the delineation report, an open-water pond was previously located within the review area. The former open-water pond appears to have been filled sometime between 2006 and 2007. The area of the pond fill currently supports a dominance of hydrophytic vegetation (invasive *Phragmites australis*) but lacks hydric soil and hydrology. The filled pond does not meet wetland criteria. There are no wetlands or waterways within the 17-acre review area.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Multiple areas on-site were investigated to determine whether they met wetland criteria. The NWI map depicts a small lobe of a larger off-site PFO wetland overlapping the farm field at the northwest corner of the review area. The 2020 aerial photo depicts what appear to be wet signatures along the northern edge of the farm field. These areas are located within an agricultural field that was planted with soybeans during the 2021 growing season. The data points taken by the consultant on August 31, 2021 near the area of the mapped NWI wetland and within the areas of the potential wet signatures depicted in the 2020 aerial (T1P4, T1P3, and T2P5) document the lack of hydrophytic vegetation and hydrology indicators. At the November 16, 2021 site inspection, an erosional feature was observed in the upland farmfield in proximity of the area of the NWI mapped wetland. This erosional feature in the upland farm field exhibited drainage patterns leading to what appeared to be an off-site wetland in the area of the NWI mapped PFO wetland. The erosional feature did not have a defined bed and bank or Ordinary High Water Mark, and therefore was not considered a potential water of the United States. None of the areas investigated within the upland farm field on November 16, 2021 supported hydrophytic vegetation, confirming the data presented in the September 7, 2021 delineation report. Additionally, based upon a review of aerial imagery and information provided in the delineation report, an open-water pond was previously located within the review area. The former open-water pond appears to have been filled sometime between 2006 and 2007. The area of the pond fill currently supports a dominance of hydrophytic vegetation (invasive *Phragmites australis*) but lacks hydric soil and hydrology. The filled pond does not meet wetland criteria. There are no wetlands or waterways within the 17-acre review area. There are no waters of the U.S. as defined by 33 CFR part 328 within the review area.
