C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

All three isolated wetlands were not separated from Buskirk Creek or a nearby intermittent drainageway by natural/artificial berms or spoil levees. No unbroken surface or shallow sub-surface water connections were found between the three isolated wetlands and nearby Buskirk Creek or a nearby intermittent drainageway. Beyond generic statements on isolated wetlands' roles in the watershed, nothing stood out during the inspection suggesting Wetlands A, B, or D singly or cumulatively had ecological interconnections with Buskirk Creek or a nearby intermittent drainageway. No possibility the three isolated wetlands--0.19, 0.16, and 0.25 acres--could be used for interstate recreation, produce fish/shellfish in any quantity, or used for industrial purposes with connection to interstate commerce.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands A and B are in an active agricultural field and may have formed in slight depressions in the fields and/or in response to plugged or broken agricultural drain tiles located much deeper in the soil profile (drain tiles emptying into Buskirk Creek were noted during this inspection and in previous inspections) . Wetlands A and B do not show up as obvious wetland features in pre-2016 Google Earth aerial imagery of the site; Wetland B clearly shows up in post-2016 aerial imagery; Wetland A does not really show up in aerial imagery--maybe because it is often in tree shadows or always appears to support growth of row crops. Corn was planted and harvested in all of Wetlands A and B in 2021. Wetland D is a Phalaris-dominated meadow located in a very slight depressional area. No indication Wetland D supports standing water during any time of year. All three isolated wetlands were not found to be contiguous with/abutting Buskirk Creek or a nearby intermittent drainageway. All three isolated wetlands were not separated from Buskirk Creek or a nearby intermittent drainageway by natural/artificial berms or spoil levees. I found nothing during the inspection that would lead me to consider Wetlands A, B, or D singly or cumulatively had ecological interconnections with Buskirk Creek or a nearby intermittent drainageway. The three isolated wetlands are very small (0.19, 0.16, and 0.25 acres) and cannot be used for interstate recreation, produce fish/shellfish in any quantity, or for industrial purposes with connection to interstate commerce .
