**The project consists of 1 non-regulated open water excavated pond approximately 1.2 acre in size. The area is surrounded by upland agricultural fields. Per aerial photographs this areas do not abut a surface water and was excavated from an agricultural field. There is not evidence to support that these areas provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that that these areas support recreational use or support fish or shellfish that can be sold for interstate or foreign commerce. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Area appears to be an excavated open water pond constructed between 1998 and 2005 (1999-2003 per submitted information). The pond was not observed in the 1998 aerial photo but was evident in the 2005 aerial photo. Further review of the applicable aerial photos and resource maps (See Section IV.A) do not support that the pond was constructed in or excavated out of a wetland or other aquatic resource. This is supported by a lack of an observed wetland or other aquatic resource signature



in the aerial photos and the resource maps do not indicate the presence of a wetland or other aquatic resource where the pond is located. There is no evidence that that the pond support recreational use nor is there any evidence to support that the pond is used for fish or shellfish production that are taken or sold for interstate or foreign commerce.
