Wetland Sections I and II as identified on the attached schematic have been determined to be isolated and non-jurisdictional under the CWA and prior to the Jan 2001 Supreme Court decision in “SWANCC,” the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the “Migratory Bird Rule” (MBR). These wetlands also lack a nexus to interstate/foreign commerce sufficient to serve as a basis for jurisdiction as outlined in 33 CFR 328.3 (1986), which defines waters of the United States. This determination is based upon information gathered from the site inspection, aerial photography, USGS Topo maps, County drainage maps, and the wetland delineation report provided by VS Engineering on behalf of Earth Source Incorporated and Allen County Highway Department, which substantiate the lack of a hydrologic surface or subsurface connection to downstream waters (i.e., the wetlands, which are depressionnal in nature, are not adjacent to a Relatively Permanent Water (RPW) and are not part of a tributary system to a Traditional Navigable Water of the United States [TNW]). Further, per the site inspection completed on March 3, 2022, there was no observed surface water or subsurface water connection (agricultural tile drain) between the subject wetlands and waters of the United States. Therefore, the wetlands were determined to be isolated non-jurisdictional wetland with no established nexus to a RPW or TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
