September 9, 2021. Also, per the delineation report, Drain 3 did not exhibit the required amount of hydrology indicators necessary to meet wetland hydrology (only one secondary indicator was recorded). Surface water was present in the roadside ditch at the December 2, 2021 Corps site inspection, however no flow into the Lowther-Neuhaus Drain was observed. Drain 3 enters a subsurface pipe with a flap-gate which terminates at the Lowther-Neuhaus Drain. The flap-gate was closed at the December 2, 2021 inspection. Surface water presence in Drain 3 could not be verified in the available Digital Globe aerial photos. The lack of surface water presence in aerial photos and at the September 9, 2021 delineation, in addition to no flow observed out of the flap-gate at the December 2, 2021 Corps inspection indicates that the roadside ditch does not support relatively permanent flow and does not appear to contribute regular flow to an RPW (Lowther-Neuhaus Drain). Roadside ditches that drain upland and do not exhibit relatively permanent flow are not jurisdictional waters of the United States. Therefore, Drain 3 is not considered a jurisdictional water of the United States.

Wetland Section I (0.03 acre), Wetland Section II (0.009 acre), Wetland Section IV (0.15 acre), and Wetland Section V (0.01 acre) are forested wetlands that are geographically isolated from Spy Run Creek and/or the Lowther Neuhaus Drain, and therefore are not adjacent to the nearest Relatively Permanent Waters (RPW). No indicators of surface water outflow from the wetlands were observed at the December 2, 2021 Corps site inspection. No indicators of potential subsurface hydrologic conveyances, such as an open sewer grate or tile inlet, were observed at any of the wetlands. The Allen County Engineering Viewer does not depict potential subsurface tile drains in the vicinity of the isolated wetlands. Therefore, the wetlands do not provide surface water flow, or hydrology via a subsurface pipe or tile drain to an RPW or TNW. The isolated wetlands are located within a forested area of Franke Park, a City of Fort Wayne Parks and Recreation owned and operated facility. The extent to which the isolated wetlands may be used by interstate or foreign travelers is unknown based upon the Corps site inspection, and available information regarding usage of Franke Park, such as that described on its website and in its master plan. No evidence of commercial harvest or other potential industrial use of the isolated wetlands for interstate commerce was observed at the Corps site inspection. Since the 2001 Supreme Court decision in SWANCC the Corps has not taken jurisdiction over isolated, intrastate waters that are non-navigable (such as wetlands Section I, II, IV, and V) through a nexus to potential use by interstate or foreign travelers for recreational or other purposes, or by other potential ties to interstate commerce. Wetlands Section I, II, IV, and V are isolated, intrastate, non-navigable wetlands that are not considered jurisdictional waters of the United States. This determination has been made based upon the wetland delineation report (as revised on December 12, 2021), the December 2, 2021 Corps site inspection, the January 2003 SWANCC Legal Memorandum, and a review of applicable resources as listed in Section IV:A of this form. ..

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
