Explain: **The project consists of five non-jurisdictional/isolated wetlands located within an agricultural field. Section I (3.25 acres) is a palustrine, emergent/scrub-shrub wetland and Section II (0.95 acres) is a plaustrine, forested wetland.**

Section III (1.41 acres), Section IV (0.55 acres) and Section V (0.11 acres) are palustrine, emergent, depressional wetlands. Hydrology for each wetland is driven by precipitation in the form of rainfall, snowmelt, and surface runoff from the surrounding agricultural fields. During the site inspection no connection to a surface water outlet for wetlands identified as Section I, II, III, IV and V was observed. Review of the USGS Map did not indicate the presence of surface water (i.e RPW TNW) in the vicinity of the wetlands; the closest mapped RPW's (Emerick Branch) is located 1.2 miles north-west of the review area and (Beal Taylor Ditch) is located 0.6 miles to the south. Sections I, II, III, IV and IV do not abut a surface water due to the depressional nature of the wetlands and distance to the closest surface water. Review of the county drainage maps obtained from the Allen County GIS website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the five wetlands to another surface water. The NHD map did not indicate potential flow paths for all five wetlands that would connect them to the Emerick Branch or Beal Taylor Ditch. All five wetlands are not separated by a berm or other man-made structure from a surface water due to their landscape position and distance to the closest mapped RPW (Beal Taylor Ditch), this is based on the site visit and review of resource maps. The depressional wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that the wetlands support recreational use nor is there any evidence to support the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require Section I, II, III, IV or V to fulfill its life cycle requirements. In addition, given the distance and multiple observed barriers (State Highway and county roads) movement from the wetlands to the closest surface water for life cycle requirements is unlikely to occur. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Section I (3.25 acres) is a palustrine, emergent/scrub-shrub wetland and Section II (0.95 acres) is a plaustrine, forested wetland. Section III (1.41 acres), Section IV (0.55 acres) and Section V (0.11 acres) are palustrine, emergent, depressional wetlands. Hydrology for each wetland is driven by precipitation in the form of rainfall, snowmelt, and surface runoff from the surrounding agricultural

fields. During the site inspection no connection to a surface water outlet for wetlands identified as Section I, II, III, IV and V was observed. Review of the USGS Map did not indicate the presence of surface water (i.e. RPW TNW) in the vicinity of the wetlands; the closest mapped RPW's (Emerick Branch) is located 1.2 miles north-west of the review area and (Beal Taylor Ditch) is located 0.6 miles to the south. Sections I, II, III, IV and IV do not abut a surface water due to the depressional nature of the wetlands and distance to the closest surface water. Review of the county drainage maps obtained from the Allen County GIS website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the five wetlands to another surface water. The NHD map did not indicate potential flow paths for all five wetlands that would connect them to the Emerick Branch or Beal Taylor Ditch. All five wetlands are not separated by a berm or other man-made structure from a surface water due to their landscape position and distance to the closest mapped RPW (Beal Taylor Ditch), this is based on the site visit and review of resource maps. The depressional wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that the wetlands support recreational use nor is there any evidence to support the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require Section I, II, III, IV or V to fulfill its life cycle requirements. In addition, given the distance and multiple observed barriers (State Highway and county roads) movement from the wetlands to the closest surface water for life cycle requirements is unlikely to occur.
