Explain: **The project consists of three non-jurisdictional/isolated wetlands. Section I (1.58 acres) and II (3.15 acres) and Section IIA (0.35 acres) are, plaustrine, emergent, depressional wetlands located within agricultural fields. Hydrology**

for each wetland is driven by precipitation in the form of rainfall, snowmelt, and surface runoff from the surrounding agricultural fields. During the site inspection no connection to a surface water outlet for wetlands identified as Section I, II, and IIA was observed. Review of the USGS Map did not indicate the presence of surface water (i.e. RPW TNW) in the vicinity of the wetlands, the closest mapped RPW (Eel River/Geller Drain) is located 0.4 miles north of the review area along with an unnamed county drainage ditch, located 1.25 miles to the west. Sections I, II, and IIA do not abut a surface water due to the depressional nature of the wetlands and distance to the closest surface water.

Review of the county drainage maps obtained from the Allen County GIS website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the three wetlands to another surface water. All three wetlands are not separated by a berm or other man-made structure from a surface water due to their landscape position and distance to the closest mapped RPW (Eel River), this is based on the site visit and review of resource maps. The depressional wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that the wetlands support recreational use nor is there any evidence to support the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require Section I, II, or IIA to fulfill its life cycle requirements. In addition, given the distance and multiple observed barriers (county roads) movement from the wetlands to the closest surface water for life cycle requirements is unlikely to occur. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: During the site inspection no connection to surface water outlets for the wetlands identified as Section I, II, and IIA was observed. Review of the USGS Map did not indicate the presence of surface water (RPW, non-RPW or TNW) in the vicinity of the wetlands, the closest mapped RPW (Eel River/Geller Drain) is located 0.4 miles north of the review area along with an unnamed county drainage ditch, located 1.25 miles to the west. Review of the county drainage maps obtained from the Allen County

GIS Website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the three wetlands to another surface water. I-MAP did indicate that a county tile was located near Section II and discharged into the unnamed ditch to the west and the Eel River/Geller Drain, however, during the site visit no connection was observed connecting Section II to the county tile. The NHD map did indicate a potential flow path that could connect Sections I, II, and IIA to the Eel River/Geller Drain. During the site visit this flow path was not observed. The NHD map was the only resource map that indicated this potential flow path, the USGS Map, Soil Survey and the aerals from 2015 and 2020 do not indicate the flow path is present. Section I, II, and IIA are not separated by a berm or other man-made structure from a surface water due to their landscape position and distance to the closest mapped RPW (Eel River and an unnamed county ditch), this is based on the site visit and supported by review of the resource maps. The depressional wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that that the wetlands support recreational use nor is there any evidence to support the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require the wetlands to fulfill its life cycle requirements. In addition, given the distance and multiple observed barriers in the aerals from 2015 and 2020 (State Highway and County Roads) movement from the wetlands to the closest surface water for life cycle requirements is unlikely to occur.
