Explain: **Section I is a 0.37 acre isolated wetland. At the November 18, 2021 inspection, an off-site open water pond was**

observed at the wetlands' eastern boundary. The remainder of the wetland boundary on-site is delineated by upland farm field. No potential discrete surface or subsurface hydrologic connection was observed during the site inspection that could connect the wetland and/or the off-site open water pond to a downstream water. The USGS NHD map and aerial imagery does not depict a potential flow-path from wetland Section I to a downstream RPW or TNW. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section II is a 0.18 acre isolated wetland. The wetland lies within a depression in the landscape and is surrounded by upland.

Upland was observed at the November 18, 2021 site inspection between wetland Section II and an off-site excavated pond. No hydrologic surface connection between wetland Section II and a downstream RPW or TNW was observed during the site inspection. There were no indicators of a discrete subsurface hydrologic connection, such as an agricultural drain tile, observed during inspection. The USGS NHD map and aerial imagery does not depict a potential flow-path from wetland Section II to a downstream RPW or TNW. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section III is a 0.20 acre isolated wetland. Wetland Section III is located within the proximity of a NWI mapped wetland. The NWI map does not depict the mapped wetland as connecting to another water. No discrete surface or subsurface hydrologic connections to a downstream RPW or TNW were observed during the November 18, 2021 inspection. A wetland delineation of the adjacent property was completed in 2013 and field verified by the Corps on August 7, 2013 (Corps file LRE-2013-00515-102-J13). The 2013 verified delineation mapped uplands on the adjacent property between the area of wetland Section III and other off-site wetlands or waterways, supporting that wetland Section III does not abut and is not adjacent to an RPW or TNW. There are no surface or subsurface drains recorded at this location on the Allen County drainage maps.

Section IV is a 0.05 acre isolated wetland. The wetland is located within a depression in the landscape and is bounded by upland. No indicators of a discrete subsurface connection, such as an agricultural drain tile, were observed during inspection. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section V is a 0.17 acre isolated wetland. A roadside swale had been excavated (historically) through the wetland along its northern boundary. Surface water was present in the roadside swale at the November 18, 2021 inspection and appeared to flow westward through a pipe culvert under Wheelock Road. However, no surface flow to a downstream RPW or TNW was observed. No evidence of a discrete subsurface connection to a tributary system, such as an agricultural drain tile, was observed at this location during inspection. Additionally, no flow-path to a downstream water could be substantiated by a review of resource maps. The USGS Topographic and NHD maps, the NWI map, Allen County drain maps, and aerial photography do not depict a possible surface or subsurface hydrologic connection between wetland Section V and a downstream RPW or TNW.

Section VI is a 0.24 acre isolated wetland. The wetland is located within a depression in the landscape and is bounded by upland. No indicators of a discrete hydrologic surface or subsurface connection to a RPW or TNW were observed during inspection. No surface or subsurface drains are recorded at this location on the Allen County drainage maps. Aerial imagery does not depict a surface water connection between wetland Section VI and a RPW or TNW.

Based upon site inspection, a review of applicable resource maps, and the delineation reports, wetlands Section I, Section II, Section III, Section IV, Section V, and Section VI are not adjacent wetlands or otherwise part of a tributary system of a TNW. Wetlands Section I, II, III, IV, V, and VI lack a link to interstate or foreign commerce sufficient to serve as a basis for jurisdiction. Wetlands Section I, Section II, Section III, Section IV, Section V, and Section VI are not jurisdictional waters of the United States.

A 250 foot long erosional feature in the upland farm field was inspected on November 18, 2021. The eroded area appears to originate from the site of a broken agricultural tile drain. The eroded area does not exhibit an Ordinary High Water Mark and, as observed during site inspection, appears to have been plowed over and planted to soybeans in the 2021 growing season. The erosional feature is not a jurisdictional water of the United States. .

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Section I is a 0.37 acre isolated wetland. At the November 18, 2021 inspection, an off-site open water pond was observed at the wetlands' eastern boundary. The remainder of the wetland boundary on-site is delineated by upland farm field. No potential discrete surface or subsurface hydrologic connection was observed during the site inspection that could connect the wetland and/or the off-site open water pond to a downstream water. The USGS NHD map and aerial imagery does not depict a potential flow-path from wetland Section I to a downstream RPW or TNW. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section II is a 0.18 acre isolated wetland. The wetland lies within a depression in the landscape and is surrounded by upland. Upland was observed at the November 18, 2021 site inspection between wetland Section II and an off-site excavated pond. No hydrologic surface connection between wetland Section II and a downstream RPW or TNW was observed during the site inspection. There were no indicators of a discrete subsurface hydrologic connection, such as an agricultural drain tile, observed during inspection. The USGS NHD map and aerial imagery does not depict a potential flow-path from wetland Section II to a downstream RPW or TNW. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section III is a 0.20 acre isolated wetland. Wetland Section III is located within the proximity of a NWI mapped wetland. The NWI map does not depict the mapped wetland as connecting to another water. No discrete surface or subsurface hydrologic connections to a downstream RPW or TNW were observed during the November 18, 2021 inspection. A wetland delineation of the adjacent property was completed in 2013 and field verified by the Corps on August 7, 2013 (Corps file LRE-2013-00515-102-J13). The 2013 verified delineation mapped uplands on the adjacent property between the area of wetland Section III and other off-site wetlands or waterways, supporting that wetland Section III does not abut and is not adjacent to an RPW or TNW. There are no surface or subsurface drains recorded at this location on the Allen County drainage maps.

Section IV is a 0.05 acre isolated wetland. The wetland is located within a depression in the landscape and is bounded by upland. No indicators of a discrete subsurface connection, such as an agricultural drain tile, were observed during inspection. No surface or subsurface drains are recorded at this location on the Allen County drainage maps.

Section V is a 0.17 acre isolated wetland. A roadside swale had been excavated (historically) through the wetland along its northern boundary. Surface water was present in the roadside swale at the November 18, 2021 inspection and appeared to flow westward through a pipe culvert under Wheelock Road. However, no surface flow to a downstream RPW or TNW was observed. No evidence of a discrete subsurface connection to a tributary system, such as an agricultural drain tile, was observed at this location during inspection. Additionally, no flow-path to a downstream water could be substantiated by a review of resource maps. The USGS Topographic and NHD maps, the NWI map, Allen County drain maps, and aerial photography do not depict a possible surface or subsurface hydrologic connection between wetland Section V and a downstream RPW or TNW.

Section VI is a 0.24 acre isolated wetland. The wetland is located within a depression in the landscape and is bounded by upland. No indicators of a discrete hydrologic surface or subsurface connection to a RPW or TNW were observed during inspection. No surface or subsurface drains are recorded at this location on the Allen County drainage maps. Aerial imagery does not depict a surface water connection between wetland Section VI and a RPW or TNW.

Based upon site inspection, a review of applicable resource maps, and the delineation reports, wetlands Section I, Section II, Section III, Section IV, Section V, and Section VI are not adjacent wetlands or otherwise part of a tributary system of a TNW. Wetlands Section I, II, III, IV, V, and VI lack a link to interstate or foreign commerce sufficient to serve as a basis for jurisdiction. Wetlands Section I, Section II, Section III, Section IV, Section V, and Section VI are not jurisdictional waters of the United States.

A 250 foot long erosional feature in the upland farm field was inspected on November 18, 2021. The eroded area appears to originate from the site of a broken agricultural tile drain. The eroded area does not exhibit an Ordinary High Water Mark and, as observed during site inspection, appears to have been plowed over and planted to soybeans in the 2021 growing season. The erosional feature is not a jurisdictional water of the United States.

There are no waters of the United States within the review area.
