Explain: **One non-jurisdictional/isolated wetland was identified on-site. Section I (0.06 acres) is a palustrine, emergent, depressional wetland situated within an active agricultural field. Hydrology for the wetland is driven by precipitation**

in the form of rainfall, snowmelt, and surface runoff from the surrounding agricultural field. During the site inspection on October 20, 2021, no connection to a surface water outlet for the wetland identified as Section I was observed. Review of the USGS Map did not indicate the presence of surface water (i.e. RPW TNW) in the vicinity of the wetlands, the closest mapped RPW (Unnamed Tributary to Beal Taylor Ditch) is located 0.28 miles to the east of the review area. Section I does not abut a surface water due to the depressional nature of the wetland and distance to the closest surface water. Review of the Allen County Drainage maps obtained from the Allen County GIS website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the four wetlands to another surface water. The wetland is not separated by a berm or other man-made structures from surface water due to its landscape position and distance to the closest mapped RPW (Unnamed Tributary Beal Taylor Ditch); this is based on the site visit and review of resource maps. The depressional wetland does not provide for interstate or foreign commerce since it is not subject to commercial use and is not susceptible for commercial use in the future. In addition, there is no evidence that the wetland supports recreational use nor is there any evidence to support that the wetland is used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require Section I to fulfill its life cycle requirements. Given the distance and multiple observed barriers (county roads), movement from the wetland to the closest surface water for life cycle requirements is unlikely to occur. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: During the site inspection no connection to surface water outlets for the wetland identified as Section I was observed. Review of the USGS Map did not indicate the presence of surface water (RPW, non-RPW or TNW) in the vicinity of the wetlands. The closest mapped RPW (Unnamed Tributary to Beal Taylor Ditch) is located 0.28 miles to the east of the

review area. Review of the Allen County Drainage maps obtained from the Allen County GIS Website (I-MAP) did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the wetland to another surface water. I-MAP did indicate that a county tile was located near the west side of Section I and discharged into Beal Talor Ditch to the south. During the site visit no connection was observed connecting Section I to the county tile. The 2005, 2015, and 2021 iMaps Aerials do not indicate that a flow path is present. Section I is not separated by a berm or other man-made structure from a surface water due to its landscape position and distance to the closest mapped RPW (Unnamed Tributary to Beal Taylor Ditch). This is based on the site visit and supported by review of the resource maps. The depressional wetland does not provide for interstate or foreign commerce since it is not subject to commercial use and is not susceptible for commercial use in the future. In addition, there is no evidence that the wetland supports recreational use, nor is there any evidence to support that the wetland is used for fish or shellfish production that are taken or sold for interstate or foreign commerce. Additionally, there are no known species that would require the wetland to fulfill its life cycle requirements. Given the distance and multiple observed barriers in the aerials from 2005, 2015, and 2021 (County Roads), movement from the wetlands to the closest surface water for life cycle requirements is unlikely to occur.
