Wetland FW-1 as identified on the attached schematic has been determined to be isolated and non-jurisdictional under the CWA and prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The wetland also lacks a nexus to interstate/foreign commerce as outlined in 33 CFR 328.3 (1986), which defines waters of the United States. This determination is based upon information gathered from aerial photography, USGS Topo maps, County drainage maps, the IANG Base storm water plan and the wetland delineation report provided by Juniper Environmental LLC, which substantiate the lack of a hydrologic surface or subsurface connection to downstream waters (i.e., the wetland, which is depressional in nature, is not adjacent to a Relatively Permanent Water (RPW) and is not part of a tributary system to a Traditional Navigable Water of the United States [TNW]). Further, per the site inspection completed on October 27, 2021, there was no observed surface water or subsurface water connection (agricultural tile drain) between the subject wetland and waters of the United States. Therefore, the wetland was determined to be an isolated non-jurisdictional wetland with no established nexus to a RPW or TNW. Open water feature OW-1 (0.7 acres) was determined to be an active dry hydrant pond (artificial fire suppression pond) which was originally created and maintained for the purpose of reserve water storage for fire emergencies. OW-1 is not a jurisdictional water of the United States. Feature EW-1 was determined to be an active stormwater detention pond (artificial waste treatment system/settling basin) created in 2017 for the purpose of storm water treatment/management. EW-1 is an artificial settling basin and is not a jurisdictional water of the United States. Feature SW-1 did not exhibit an Ordinary High-Water Mark (OHWM) or a defined bed or bank and was originally created for the purpose of roadside drainage. SW-1 is not a jurisdictional water of the United States. Feature IS-1 did not exhibit an OHWM, defined bed and bank or evidence of sediment sorting and was considered part of an active stormwater collection network within the base. IS-1 receives stormwater from an underground collection system and then conveys flow via a concrete lined swale into larger upland dry detention basin (artificial waste treatment system/settling basin). IS-1 is not a jurisdictional water of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
