- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **Two isolated wetlands (Section I and Section II) were identified and delineated within the Approved JD request area (Wetland Delineation Report for Waters Property, revised January 4, 2022).**

Wetland Section I (0.20 acres) is separated from Wetland Section II by a disturbed area (utility ROW) that does not meet wetland criteria per the Corps site inspection and the datapoint recorded by the consultant on March 9, 2022. No surface water outlet from Wetland Section I was observed at the Corps site inspection. No indication of a potential subsurface hydrologic conveyance, such as a tile or pipe inlet was observed at Wetland Section I. Allen County drain maps do not depict a surface or subsurface drain at Wetland Section I. No evidence of commercial harvest or industrial use of the wetland was observed at the Corps site inspection. Wetland Section I is not adjacent to a Relatively Permanent Water (RPW) or Traditional Navigable Water (TNW). Therefore, Wetland Section I is considered isolated and is not a regulated water of the United States.

Based upon observations at Corps site inspection, Wetland Section II (0.98 acres on-site) appears to continue off-site, beyond the limits of the review area. No surface drain outlet, or indicator of a subsurface hydrologic conveyance, such as an inlet to a pipe or tile drain was observed at Wetland Section II during the Corps site inspection. Allen County drain maps do not depict a surface or subsurface drain at Wetland Section II. Based upon delineation report, Corps site inspection, and the USFWS NWI map, Wetland Section II is isolated and is not adjacent to an RPW or TNW. No evidence of commercial harvest or industrial use of the wetland was observed at the Corps site inspection. Wetland Section II is an isolated wetland and is not a regulated water of the United States. ..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
