been subject to sand/gravel extraction and appear to have formed in result of quarry activity. No surface water outlets at the depressional wetlands Section I, Section II, Section IV, or Section V were observed at the Corps site inspection. No indicators of a potential subsurface hydrological conveyance, such as an inlet to a pipe or tile drain were observed at wetland Section I, Section II, Section IV, or Section V at the Corps site inspection. Wetlands Section I, Section II, Section IV, and Section V are geographically isolated and are not adjacent to a Relatively Permanent Water (RPW) or a Traditionally Navigable Water (TNW). As quarry activities have ceased, the isolated wetlands do not appear to have a connection to foreign or intrastate commerce. No evidence of current commercial harvest or industrial use of the isolated wetlands was observed at the Corps site inspection. Based upon the site inspection and review of applicable resource maps (see Section IV.A), wetlands Section I, Section II, Section IV, and Section V are isolated and are not regulated waters of the United States.

Per the Corps site inspection, the 168 linear foot erosional feature delineated between Wetlands Section VIII and Section VI does not have a defined bed and bank or Ordinary High Water Mark (OHWM) and does not meet the definition of a Relatively Permanent Water (RPW). The 168 linear foot erosional feature is not a regulated water of the United States. ..

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
