within a previously logged/cleared forested area. ED 1 (423 linear feet) is an ephemeral drain that appears to be an erosional feature that loses a pattern of discrete flow and becomes undefined surface flow as it continues west from the western edge of Section I wetland. Hydrology for the wetlands and drain are driven by precipitation in the form of rainfall, snowmelt, and surface runoff from the surrounding land. During the site inspection on June 29, 2022, no connection to a surface water outlet for the wetlands and drain were identified. Review of the USGS Map did not indicate the presence of surface water (i.e RPW TNW) in the vicinity of the wetlands; the closest mapped RPW (Silver Lake) is located 0.3 miles to the west of the review area. The wetlands (Section IA, I, II) do not abut a surface water due to the depressional nature of the wetlands and distance to the closest surface water. Review of the drainage feature layer of Steuben County GIS maps (2019, 2022) do not indicate the presence of a subsurface connection. No sign of a subsurface drain (i.e. standpipe) was observed during the site visit that could carry water from the three wetlands to another surface water. The wetlands are not separated by a berm or other man-made structures from surface water due to their position in the landscape and distance to the closest mapped RPW (Silver Lake); this is based on the site visit and review of resource maps. The wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. In addition, there is no evidence that the wetlands support recreational use nor is there any evidence to support that the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce. .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** During the site inspection, no connection to surface water outlets for wetlands Section IA, I, II and ephemeral drain ED1 were observed. Review of the Steuben County GIS Maps did not indicate the presence of surface water (RPW, non-RPW or TNW) in the vicinity of the wetlands. The closest mapped RPW (Silver Lake) is located 0.3 miles to the west of



the review area. Review of the Steuben County GIS maps (drainage feature layer) obtained from the Steuben County GIS Website did not indicate the presence of a subsurface connection and no sign of a subsurface drain (i.e. standpipe) was observed that could carry water from the wetlands to another surface water. The ephemeral drain (ED1) is an erosional feature that begins at the western edge of Section I wetland and flows west where it eventually loses characteristics of discrete flow, becoming an area of undefined surface flow near the western property border. The 2019 and 2022 GIS aerials do not indicate that a flow path is present. The wetlands are not separated by a berm or other man-made structure from a surface water due to its landscape position and distance to the closest mapped RPW (Silver Lake). This is based on the site visit and supported by review of the resource maps. The depression wetlands do not provide for interstate or foreign commerce since they are not subject to commercial use and are not susceptible for commercial use in the future. There is no evidence that the wetlands support recreational use, nor is there any evidence to support that the wetlands are used for fish or shellfish production that are taken or sold for interstate or foreign commerce or used for industrial purposes in interstate or foreign commerce. Additionally, there are no known species that would require the wetlands and drain to fulfill its life cycle requirements.
