inspection on April 26, 2022, Wetland 2 is located within a topographic depression in a previously farmed portion of the review area that appears to have soil compaction. No surface water outlet from Wetland 2 was observed at the Corps site inspection. There was no indication of a subsurface hydrologic conveyance (such as an agricultural tile drain inlet or standpipe) observed at the Corps site inspection. Prior to the January 2001 Supreme Court decision in "SWANCC," Wetland 2 would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Based upon the Corps site inspection, the delineation report, and a review of the resources and data listed in Section IV of this form, Wetland 2 is not part of a tributary system of a Traditional Navigable Water (TNW) and is not a jurisdictional water of the United States. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
